 - c. Refers to XXIV Corps radio GCT 2270 of 14 March and states:
 - (1) Konei Maru carried 169 Jap repats from S. Korea and 1 Jap repat from N. Korea.
 - (2) Included within 169 Jap repats from S. Korea were 8 previously carried on census report.
 - d. States transportation for return 31 members of crew of Ohtori Maru was requested in XXIV Corps radio GCT 2850 of 1 April.
 - e. States total Japs repatriated from Manchuria via S. Korea as of 30 March is 51,388.
2. Ourad ZX 41203 of 2 April 47:
 - a. States our latest figures show 49 Japs still in S. Korea and requests confirmation (para 1 a above).
 - b. Refers to XXIV Corps radios GCT 2045 of 7 March, GCT 2270, of 14 March and GCT 2737 of 28 March which reported numbers of repats on Kishin Maru, Konei Maru and Kogane Maru respectively; and asks if crew of Ohtori Maru included in any of these figures (ship restituted to owners).
 - c. Requests in future sailing dispatches for ships departing Pusan with repats give breakdown on those from S. Korea, N. Korea, and in special category such as crew of Ohtori Maru.
3. a. Reference para 1 a above, next status report will show only 41 Japs in S. Korea.
 - b. Reference para 1 b above, Jap repats on Kishin Maru were carried on Status report of 24 Feb - 2 Mar 47 as being from N. Korea. However, 24 Div reported only 356 Japs aboard instead of 369. The figure 356 was used in our report.
 - c. Reference para 1 c above:
 - (1) XXIV Corps radio GCT 2270 of 14 March reported 65 Jap repats on Konei Maru, not 169. 24 Div radio KVC 5277 of 17 March confirmed figure of 65.

(2) It is believed the reference is erroneous. XXIV Corps radio GCT 2737 of 28 March reported 170 repats aboard Kogané Maru. 24 Div radio KVC 5513 of 30 March reported 169 repats aboard, and the 169 were carried as coming from N. Korea via S. Korea on Status Report of 24 - 30 March 1947. Correction will be made in next status report to show 168 Japs from S. Korea and 1 from N. Korea.

d. Reference para 1 d above, XXIV Corps radio GCT 2850 of 1 April 1947 has not been received at GHQ (AG Radio & Cable - Capt Guthrie).

e. Reference para 1 e above, our records as of 30 March 1947 show 293,904 Japs repatriated from north of 38° N. latitude via S. Korea. No attempt is made to differentiate those from Manchuria and those from N. Korea. The figure 293,904 will have to be reduced by 168 persons (see para 3 c (2) above).

3. Ourad Z 36750 of 28 February (originated by CPC) to CG USAFIK, states SS "Dai-3 Ohtori Maru" is scheduled to arrive Pusan 9 March 47 for restitution, and requests arrangements be made to repatriate Japanese crew.
4. Since 9 March, following ships have departed Pusan for Japan:
 - a. Kishin Maru with 369 Japs (XXIV Corps radio GCT 2045 of 7 Mar).
 - b. Konei Maru with 65 Japs (XXIV Corps radio GCT 2270 of 14 Mar).
 - c. Kogane Maru with 170 Japs (XXIV Corps radio GCT 2737 of 28 Mar).
5. Radios mentioned in para 4 above did not state if Japanese were from S. Korea, crew of No. 3 Ohtori Maru, or repats from N. Korea via S. Korea. It is impossible to keep repatriation figures correct if a breakdown is not given.





1. Reference is made to:

a. Memorandum from the Supreme Commander for the Allied Powers, file AG 370.05 (7 May 46)GC, (SCAPIN-927), dated 7 May 1946, subject as above, as amended.

b. Memorandum from the Supreme Commander for the Allied Powers, file AG 000.5 (10 Dec 46)GC, (SCAPIN-1391), dated 10 December 1946, subject: "Suppression of Illegal Entry into Japan."

c. Memorandum from the Supreme Commander for the Allied Powers, file AG 014.33 (14 Feb 47)GA, (SCAPIN-1527), dated 14 February 1947, subject: "Repatriation of Non-Japanese."

2. The Kishin Maru has been designated to lift approximately 100 Korean illegal immigrants from Sasebo to Pusan, Korea, and 265 Japanese nationals and 17 Formosans from Pusan to Sasebo. Five of these Formosans are being deported from Korea. The ship will depart from Sasebo on or about 25 February 1947.

3. The Imperial Japanese Government will:

a. Place approximately 100 Korean illegal immigrants, now at Sasebo, aboard the Kishin Maru.

b. Furnish sufficient Japanese guards aboard ship to insure delivery of Korean illegal immigrants to the custody of the Commanding General, XXIV Corps.

c. Direct Japanese guards to accept custody at Pusan, Korea, of the 5 Formosan deportees and insure their delivery to proper authorities at the Sasebo Reception Center.

d. Receive and process Japanese being repatriated from Korea in accordance with the provisions of reference paragraph 1 a above.

BASIC: Memo to IJG, file AG 014.33 (Feb 47)GC, (SCAPIN-), dated February 1947, subj: "Repatriation".

e. Receive, process and hold the 17 Formosan repatriates at the Sasebo Reception Center pending arrangements for onward shipping, in accordance with the provisions of reference paragraph 1 c above.

f. Insure the 5 Formosan deportees are held under guard until they can be shipped to Formosa.

1. BASIC ACTION: Phone call from Capt Dalton, XXIV Corps, at 1055 hours 20 February 1947, during which he:

a. Stated a radio (GCT 1452, 19 Feb 47) had been sent, requesting shipping to lift 165 Japanese be dispatched to arrive Pusan on 26 February 1947.

b. Corrected the number of spaces in above mentioned radio to 265 Japanese, and included 17 Formosans (5 of which are being deported).

2. CG 24th Inf Div radio KVC 4886 of 19 February 1947 states there are 102 illegal Koreans being held at Sasebo.

3. Memo for IJG, file AG 000.5 (10 Dec 46)GC, (SCAPIN-1391), dated 10 December 1946, subject: "Suppression of Illegal Entry into Japan," in part:

a. Directs Japanese Government to:

(1) Outload Korean illegal immigrants from the Sasebo Reception Center on shipping designated for this purpose.

(2) Furnish Japanese police for guards aboard repatriation ships transporting Korean illegal immigrants.

b. States necessary Allied guards to lend the necessary support and prestige to Japanese police guards and coordinate their activities may be secured on request to the local Allied commander.

4. Memo for IJG, file AG 014.33 (14 Feb 47)GA, (SCAPIN-1527), dated 14 February 1947, subject: "Repatriation of Non-Japanese," in part states repatriates arriving Japan for onward shipment will be received, cared for, assembled at Sasebo Reception Center, processed for shipment and held in Sasebo Reception Center pending arrangements for onward shipping.

5. In view of fact that the ships¹⁵ carrying illegal Koreans to Pusan, and will backload Japanese and Formosans, it is not advisable to place U. S. guards aboard, since the ship may be quarantined when it arrives back at Sasebo.

6. RECOMMENDED ACTION:

a. Informing IJG concerning paragraphs 1 and 5 above.

b. Directing IJG to:

- (1) Place illegal Koreans aboard KISHIN MARU, ETD Sasebo, 25 February 1947.
- (2) Place sufficient Japanese guards aboard KISHIN MARU to insure delivery of illegal Koreans to custody of CG XXIV Corps.
- (3) Direct Japanese guards to accept custody of 5 Formosan deportees at Pusan and insure their delivery to proper authorities at Sasebo (included at request of G-1).
- (4) Hold 17 Formosans at Sasebo Reception Center pending arrangements for onward shipping (included at request of G-1).
- (5) Insure 5 Formosan deportees are held under guard until they can be shipped to Formosa (included at request of G-1).

7. CONCURRENCES: SCAJAP (Comdr Reinhardt)

8. RECOMMENDATION: Approval and dispatch of attached radio, Memo to IJG, and letter to CG Eighth Army. (IJG - Mr. Suzuki, C.L.O., has been notified verbally.)



2. The Kishin Maru has been designated to lift approximately 100 Korean illegal immigrants from Sasebo to Pusan, Korea, and 265 Japanese nationals and 17 Formosans from Pusan to Sasebo. Five of these Formosans are being deported from Korea. The ship will depart from Sasebo on or about 25 February 1947.

3. The Imperial Japanese Government will:

a. Place approximately 100 Korean illegal immigrants, now at Sasebo, aboard the Kishin Maru.

b. Furnish sufficient Japanese guards aboard ship to insure delivery of Korean illegal immigrants to the custody of the Commanding General, XXIV Corps.

c. Direct Japanese guards to accept custody at Pusan, Korea, of the 5 Formosan deportees and insure their delivery to proper authorities at the Sasebo Reception Center.

d. Receive and process Japanese being repatriated from Korea in accordance with the provisions of reference paragraph 1a above.



2. XXIV Corps radio TFGCT 2544, 26 Sept 46, requests shipping space to lift 1600 Japanese be sent to Inchon daily.
3. Ourad ZX 09062, 19 July, reopens Pusan to repatriation, and states Japanese returning from Korea to Japan will be lifted from Pusan or Chuminjin to Sasebo on shipping requested 1 week in advance by USAFIK from SCAJAP.
4. Information contained in TFGCT 2602 (par 1 above) was received via phone on 11 October, and necessary action has already been taken. In a telephone conversation on 14 Oct 46, XXIV Corps (Capt Dalton, G-3 Section) stated they were not ready to receive Koreans from Japan. 3. Also informed Capt. Dalton that the Choki Maru had sailed for Inchon without orders from SCAJAP and will arrive on 9 Oct. Told him to load it and return it to Hakata.

4. Capt. Dalton replied that in view of the Choki Maru arriving on 9 Oct at Inchon (capacity 600) it would not be necessary to dispatch a third ship to arrive at Pusan on 12 Oct.

MEMO for RECORD:

1. Called Capt Dalton, XXIV Corps at 1130 10 October to inquire if more spaces would be required at Fusan to satisfy the 2500 space requested for 12 October. (1500 spaces had already been sent to Fusan to arrive 12 September and 600 spaces to Inchon. SCAJAP radio 080816 Z).

2. Capt Dalton replied that no more spaces would be required at Fusan on 12 October since the Choki Maru (600 spaces) had been dispatched from Inchon to Fusan thus giving Fusan 2100 spaces for 12 October.

3. Capt Dalton also stated:

a. 1000 extra persons were loaded on the Tatsuhi (capacity 3000).

b. 2200 loaded on the Shinyo Maru.

c. 710 loaded on the Kainei Maru.

d. During last 36 hours, 145 persons have arrived in camp (Reception Center).

e. 3000 Japs remain on Onjin Peninsula. After they come down to Fusan, another 6 days will be required to finish their processing. This will clean the area of all except stragglers.

f. A radio is being sent to SCAJAP this morning requesting 556 spaces to arrive Chumingin 18 October.

g. No more spaces required at present. XXIV Corps will request them when desired.



1. BASIC ACTION: XXIV Corps radio TFGCT 2552, 29 September 46 which states there are 21,577 Japanese in compounds in Korea and requests 1600 shipping spaces per day be made available at Inchon.

2. XXIV Corps radio TFGCT 2544, 26 September 46 requested 1600 shipping spaces per day at Inchon, the first to arrive earliest. It states ships may be delayed at Inchon due to land transportation difficulties but will be loaded and dispatched as rapidly as possible. Action taken here during period 29 Sept (date first ship arrived) to 5 Oct (see Par 3 below) sets up a total of 16,700 spaces or at a rate of 2400 spaces per day.

3. SCAJAP radio 300206 Sept 46 sets up the TATSUHI MARU (capacity 3,000) to arrive Inchon on or about 5 Oct 46, an additional lift not included in the 13,700 spaces listed in action radio.

4. In telephone conversation with Lt. Col. Shott, G-3 Sect XXIV Corps, on 30 Sept, he stated they could outload 1600 per day, in addition to shipping already set up, beginning 4 October 46.

5. RECOMMENDED ACTION: Radio to XXIV Corps reassuring them that their requirements will be met.



1. BASIC ACTION: Telephone call on 25 September 1946, from G-3, XXIV Corps, who stated there are 15,000 Japanese concentrated in camps in Southern Korea. At least 1,000 Koreans drift across the 38° parallel each day, and camps are now overcrowded. Due to the railroad strike in Southern Korea, it is impossible to move these repatriates to Pusan, so it was requested that ships scheduled to arrive Pusan on and after 28 September be held in Japan. XXIV Corps intends moving repatriates via truck into Inchon beginning 26 September. It was requested that shipping to lift 1600 per day be dispatched to Inchon earliest.

2. SCAJAP radio 250708 September cancelled all sailings to Pusan which would arrive there on and after 28 September.

3. Due to the increased length of voyage, and the critical shortage of shipping, it is possible to furnish only the following ships at this time:

Localized railroad strikes are spreading over entire South Korea Area and it is expected all railroad operating personnel will be on strike on 25 Sept. These strikes may extend to other public utilities and industries. Therefore, all commanders will review those missions assigned by ALPLAN toward taking necessary measures adjusting to the present low troop strength. It is the intention of the CG that military installations and functions will continue to operate smoothly throughout the strike. Commanders will take the following steps at this time: A: (Instruct all personnel under military control to avoid assemblages of Koreans). B: Maintain adequate security measures over installations now under their charge. C: Screen personnel for railway specialists enumerated on pages 143 of WD TM 12-427 and screen for water plant operators, electric power plant operators, and signal personnel. Nbr and MOS of such personnel will be reported at earliest to this HQ. Major commands will be prepared to assemble these specialists on 6 hours notice. Commanders will be prepared to operate auxiliary light and water filtration plants under their control in the event of a utility strike.

SUBJECT : Repatriation of Japanese from Northern Korea via
Southern Korea.

1. During the past two months there has been a build-up in the repatriation of Japanese formerly resident in North Korea through South Korea. This in essence amounts to clearing repatriates from North Korea through South Korea.

2. Following information showing the extent of this problem is furnished for consideration:

a. The figures for the period 29 July 1946 to 29 September 1946 are as follows:

b. Since Pusan is a cholera port, ships evacuating these Japanese must be quarantined in Japan thus precluding their use for other tasks during the quarantine period. Five Liberty ships and one LST bearing these Japanese are presently in quarantine in Japan. One of these Liberty ships has been in quarantine since 26 August 1946, with estimated time of release of 28 September.

c. In addition to the ships presently in quarantine, one Liberty ship, three LST's and 12 Japanese ships are committed for lifts for the period 20-29 September 1946.

3. XXIV Corps has not been able to conclude an agreement with the Soviets whereby the latter will accept repatriates apprehended crossing





MEMO FOR RECORD:

1. Action is XXIV Corps radio TFGCT 2476, dated 21 August.
2. Ourad ZX 09062, 19 July, states that Japanese returning from Korea to Japan will be lifted from Pusan or Chumunjin to Japan on shipping requested 1 week in advance by USAFIK from SCAJAP, info SRLUF. Listed below are the several requests by USAFIK for shipping and action taken here to furnish same in furtherance this plan.
3. a. XXIV Corps radio TFGCT 2458, 12 Aug requests that shipping space to lift 1000 Japanese repatriates arrive Pusan 14 Aug, space for 1500 to arrive 20 Aug and space for 1000 to arrive 21 Aug.
b. SCAJAP assigned 1 LST for the lift on 14 Aug. SCAJAP radio 150500 designated Liberty John A. Campbell VO22 to lift illegal Koreans from Sasebo to Pusan, to arrive at Pusan on 21 Aug, and lift 2500 Japanese from Pusan to Sasebo.
c. COMFLTACT Sasebo radio 210723 Aug is sailing dispatch for VO22, ETA Pusan 212200 August. (24th Inf Div radio KVC 1717, 21 August, states VO22's ETA Pusan is 220700 August.) Ship actually arrived at Pusan on 22 August.
4. a. XXIV Corps radio TFGCT 2466, 16 Aug, requests shipping space at Pusan to lift 2000 Japs on 23 Aug and 1800 on 24 August.
b. SCAJAP radios 190558 and 190600 Aug set up Liberty Jefferson Davis V001 to arrive Pusan on 24 Aug, and divert Liberty George V. L. Meyer V004, then enroute Kure to Hulutao, to arrive Pusan 23 Aug. (SCAJAP states CMMC has information that V004 arrived Pusan on 21 August instead of 23 Aug.)
5. a. XXIV Corps radio TFGCT 2467, 16 Aug, has not been received in this headquarters (AG radio and cable) or by SCAJAP. In a telephone conversation on 23 Aug with XXIV Corps (Col Coolidge), it was learned that this radio requested 1 LST arrive at Chumunjin on 23 August to lift 502 Japanese repatriates.
b. Col Coolidge was told we would set up an LST at once for this lift. SCAJAP is scheduling the LST Q098 with ETA Chumunjin 27 August (Lt Comdr Shields).
6. a. XXIV Corps radio TFGCT 2472, 19 Aug, requests shipping space be sent to Pusan to lift 2200 Japs on 25 Aug and 2000 on 26 Aug.
b. SCAJAP radios 200140 and 200156 Aug set up Liberty James King V009 to arrive Pusan 25 Aug and Liberty Peter T. Barnum V003 to arrive Pusan 26 Aug.

7. a. XXIV Corps radio TFGCT 2473, 20 Aug, requests shipping space to lift 2500 Japs be sent to Pusan to arrive 28 Aug.

b. SCAJAP radio 210124 Aug sets up Liberty Sara Bache VO18 to arrive Pusan 28 Aug.

8. In every case, shipping has been set up upon receipt of each request from XXIV Corps. To date, all ships have arrived on or prior to the time they were requested, except for the VO22, which was delayed due to the typhoon. The VO22 arrived 1 day late. However, the VOO4 arrived in Pusan 2 days early so that it could have been loaded if facilities at Pusan were overcrowded.

9. Col Coolidge (XXIV Corps) stated the reason the action radio was sent was to emphasize the need for repatriation shipping arriving on the dates requested.

10. Recommend dispatch of attached radio.

11. SCAJAP (Lt Comdr Shields) concurs.

12. This matter concerns Korea.

13. This completes action on the radio mentioned in para 1 above.
