The bearer, upon establishing his identity that he is the individual described in paragraph 1a and b above, is authorized to retain in his possession and wear the following Class X clothing, United States Government property, for a period of fifteen (15) days, but not subsequent to the date indicated in 1c above:

- a. 1 ea belt, waist web, OD-3, w/clip, w/o buckle.
- b. 1 pr boots, service, combat, russet or tropical.
- c. 1 ea buckle, web belt, bronze, bronze finish,  $1\frac{1}{2}$  inch.
- d. 1 ea cap, garrison, khaki.
- e. 1 ea cap, garrison, OD.
- f. 1 ea drawers, cotton short, OD.
- g. 1 ea drawers, winter, 50 per cent cotton, 50 per cent wool, natural gray.
- h. 1 ea jacket, wool, OD.
- i. 1 ea necktie, cotton mohair, khaki or OD-51.
- j. 1 ea overcoat, wool, OD.
- k. 1 ea shirt, cotton khaki, shad 1, stand-up collar, 8.2 oz., or poplin khaki shade 1, stand-up collar, M-1949.
- l. 1 ea shirt, flannel, OD, stand-up collar.

- m. 1 pr socks, wool, cushion sole or substitute.
- n. 1 pr trousers, cotton khaki.
- o. 1 pr trousers, wool, OD
- p. 1 ea undershirt, cotton quarter-sleeve, OD.
- q. 1 ea undershirt, winter, 50 per cent cotton, 50 per cent wool, natural gray.

(Under no circumstances will the certifying officer authorize United States military clothing in excess of the above for retention by the individual. Items not in possession of the individual will be lined out and initialed by the certifying officer.)

3. Subsequent to the expiration of the date indicated in 1c above, articles of outer military clothing (other than shoes) which have not been altered so as to no longer resemble United States military clothing will be immediately confiscated by law enforcement agencies in Japan.

4. The bearer has been cautioned to retain this certificate in his possession at all times while wearing any article of outer United States military clothing.



1. Reference Check Sheet, G-1 to G-2 and CAS, which outlines the policy to be followed with reference to the continued wearing of uniforms by returned Korean volunteer personnel (Incl 2). It will be noted that the returned volunteers are authorized to wear the US military uniform for only fifteen days after their return to Japan. As an aid in the enforcement of this provision, each returnee is given a certificate which indicates the time period authorized for the wearing of the uniform. It will be further noted that the individual is permitted to wear the uniform after the expiration of fifteen days provided it is so altered as to no longer resemble a US military uniform. An exception to the above may be encountered in that a few of the early returnees were not issued certificates of authorization for their uniforms. These few were returned before the

## MEMO FOR RECORD:

The ab is in response to a query fr 441 (Lt Col Mooney) rqsting instructions as to CIC policy re uniforms issued by US Army to Kor Vol for UN Ser, who have been returned to Jap. Police action agreed upon after conferences between Capt Calvert for CI Div, and Mr Mulbar, Lt Col Speigel, and Mr Shupak for PSD. Mr Shupak is preparing instructions to the police to cause the provisions of G-1 Chk Sht (Incl 2) to be implemented. Original stand of PSD was that police have no authority to intervene in a matter which lies between the US Army and individual Kors in Jap. Police action is based on clause in Incl 2, which provides "Korean volunteers returned to Japan by CG, Eighth Army are considered residents of Japan in the same status as other Korean residents."

1. Certain Korean residents of Japan were recruited for service in Korea in August and September 1950, and were transported to Korea by US military transportation. Subsequently, some of these volunteers have been returned to Japan at the request of CG, Eighth Army.
  2. The clothing worn by these individuals upon return to Japan has been US military uniforms, which has been marked as "Class X" by JLCOM after the individuals re-entered Japan. It is anticipated that additional individuals in this category will be returned in the future and be provided transportation to their homes, wearing "Class X" uniforms.
  3. Korean volunteers returned to Japan by CG, Eighth Army, are considered residents of Japan in the same status as other Korean residents. To permit the individuals to return to their homes and have sufficient period of time to obtain civilian clothing, or to alter the Class X clothing so it no longer resembles the US military uniform, the Korean Mission has been informed of the following:
    - a. Korean volunteers returned to Japan prior to this date are authorized to continue to wear the Class X clothing for not more than 15 days from this date.
    - b. Korean volunteers entering Japan in the future will be authorized to continue to wear Class X clothing for not more than 15 days after arrival in Japan.
    - c. Subsequent to expiration of the 15-day periods referred to above, articles of outer military clothing (other than shoes) which have not been altered so as to no longer resemble US military clothing will be confiscated by appropriate law enforcement agencies in Japan.
  4. CG, JLCOM, has been authorized to issue an appropriate certificate authorizing Korean volunteers which may be returned to Japan in the future to wear "Class X" clothing for a period not to exceed 15 days after return to Japan.
  5. Request the foregoing be disseminated to CIC for information and to the Japanese police, and Civil Affairs personnel by G-2 or CAS, as appropriate for surveillance and implementation. Any items of clothing confiscated should be turned in to the nearest JLCOM installation for disposition.

TO: All MP Units Throughout Japan

1. Certain Korean residents of Japan were recruited for service in Korea in August and September 1950, and were transported to Korea by US military transportation. Subsequently, some of these volunteers have been returned to Japan at the request of CG, Eighth Army.

2. The clothing worn by these individuals upon return to Japan has been US military uniforms, which has been marked as "Class X" by JLCOM after the individuals re-entered Japan. It is anticipated that additional individuals in this category will be returned in the future and be provided transportation to their homes, wearing "Class X" uniforms.

3. Korean volunteers returned to Japan by CG, Eighth Army, are considered residents of Japan in the same status as other Korean residents. To permit the individuals to return to their homes and have sufficient period of time to obtain civilian clothing, or to alter the Class X clothing so it no longer resembles the US military uniform, the Korean Mission has been informed of the following:

a. Korean volunteers returned to Japan prior to this date are authorized to continue to wear the Class X clothing for not more than 15 days from this date.

b. Korean volunteers entering Japan in the future will be authorized to continue to wear Class X clothing for not more than 15 days after arrival in Japan.

c. Subsequent to expiration of the 15-day periods referred to above, articles of outer military clothing (other than shoes) which have not been altered so as to no longer resemble US military clothing will be confiscated by appropriate law enforcement agencies in Japan.

4. CG, JLCOM, has been authorized to issue an appropriate certificate authorizing Korean volunteers which may be returned to Japan in the future to wear "Class X" clothing for a period not to exceed 15 days after return to Japan.

5. Any items of clothing confiscated should be turned into the nearest JLCOM installation for disposition.

MEMORANDUM: The Chief of the Korean Diplomatic Mission in Japan

SUBJECT: Korean Volunteers

1. Reference is made to:
  - a. Memorandum for Record, subject: South Korean Augmentation of US Forces, 27 October 1950, copy of which was furnished the Korean Mission.
  - b. Memorandum for the Chief of the Korean Diplomatic Mission in Japan, AG 091.711 (1 Dec 50)GA, subject: Korean Volunteers, 1 December 1950.
  - c. Korean Mission Memorandum for General Headquarters, Supreme Commander for the Allied Powers, subject: Korean Volunteers, 11 January 1951.
2. The Korean Mission was informed by reference (a) that the United States forces accepted no obligation to keep the personnel loaned from the Republic of Korea Army (either volunteers from Japan or recruits from Korea) with United States units or to return them to Japan. Further, it was indicated that when the Republic of Korea Army personnel (either volunteers from Japan or recruits from Korea) were no longer required by United States units, they would be released to the Republic of Korea Army. It was agreed, however, that United States forces would furnish transportation to Japan for those volunteers who were residents of Japan and had been transported by United States Army means from Japan to Korea, provided proper reentry clearance into Japan was obtained.
3. This headquarters assumes that appropriate authorities in the Republic of Korea Government were notified of the enlistment in the Republic of Korea Army of the volunteers in question. When contacted by United States military authorities in Korea, however, the Republic of Korea Army reported that there were no records of the individuals concerned and no indication that they were members of the Republic of Korea Army.
4. In view of the existing facts; i.e., (1) the individuals were no longer required by United States military units, (2) no

records were available to the Republic of Korea Army to substantiate that the individuals were in fact members of the Republic of Korea Army, (3) the individuals were given the opportunity but refused to enlist in the Republic of Korea Army in Korea, and (4) the Republic of Korea Army was unwilling to force induction on those who did not desire to become members of the Republic of Korea Army; the individuals had no basis for continued stay in Korea and were returned to Japan in accordance with the agreement referred to in paragraph 2.

5. This headquarters considers that the Korean volunteers who have been returned to Japan are residents of Japan. Travel of these individuals from Japan to Korea, or to any other country, must be accomplished in accordance with existing policies governing travel abroad of residents of Japan. Application for such travel must be submitted for approval on an individual basis, as prescribed in current Supreme Commander for the Allied Powers regulations.

6. To facilitate the return of the volunteers to their homes, all volunteers returned to Japan have been permitted to retain military uniforms until they can obtain civilian clothing. It is requested that the Korean Mission disseminate information to the volunteers returned prior to this date that they are authorized to continue to wear the items of United States military uniform for not more than fifteen (15) days from the date of this memorandum. Korean volunteers returned in the future will be informed on return to Japan that they are authorized to wear retained items of the United States military uniform not more than fifteen (15) days from the date of their re-entry into Japan. Subsequent to expiration of the 15-day periods referred to above, articles of outer military clothing (other than shoes) which have not been altered so as to no longer resemble United States military clothing, will be confiscated by appropriate law enforcement agencies in Japan.
