

ARREST OF TERRORIST ORGANIZATIONS IN VARIOUS DISTRICTS

## (Second Report)

The terrorist organizations, which have considerably become influential after the end of war, can be divided into two groups.

1. Gamblers and street-stall brokers organized by a family or a group.
2. Other gangsters.

According to the recent investigation, there are 489 groups of gamblers consisting of 16,117 members, 504 groups of street-stall brokers having 29,559 members and 267 gangster groups with 7,375 members. In view of the nature of these groups, we are afraid that there are many which are not counted in the above statistics. Therefore, it is of the utmost importance to grasp the entire feature by conducting the thorough investigation.

As reported in the Edition X of "Report on Criminal Affairs" issued by Home Ministry. The Home Ministry is vigorously devoting itself to the control of terrorist organization. The Metropolitan Police Board has conducted the wholesale arrest of Sekine Gumi, Kyokuto Gumi, Otsugumi and other well-know gamblers' groups. In Osaka the groups of Nando-Kai and the Minami family of Hanshin were all arrested. In other districts the famous groups were also

mostly arrested. As they have a strong foundation and are solidly organized, it is considered difficult to get rid of the social unrest without doing the thorough and continuous control. It is for this reason that we stress the importance of strengthened control.

In the wholesale arrest conducted by the Metropolitan Police Board and other 15 prefectures since June 7, 1947, 962 criminals were arrested. The gist of the important arrests are as follows:

1. The Metropolitan Police Board has been conducting the control of terrorists since June, 1947. Up to October 8, the followings were arrested:

We have already reported on the criminal cases of some of the above groups. Sekine Ken, age 51, the boss of Sekine Gumi, who has recently been reported in newspapers, had a considerable number of followers organized into the staff general, staff and sub-staff, and had engaged in violation, intimidation, pillage at gambling houses, etc. He was hated even by gamblers.

In conspiracy with his follower, Kizu Masao, Sekine, interfering with the lease of construction ground for special restaurants, intimidated Yokoyama Genji, sub-manager of the Association at Terajima-Cho, Sumida Ward, and two others and extorted ¥ 50,000 in cash from them in January, 1946.

On 24 December 1946, when the construction was started, he threatened UNAMI Utaro, civil engineer, and deprived him of ¥ 50,000, saying that if UNAMI did not offer salutation, he would not allow the construction to progress satisfactorily. He was possessed of machine guns and Japanese swords. His follower, Mukozato Masabumi, had acted as a bodyguard of Ueki Hiroaki, enterpriser of Cabaret Ginza Club, Nishi 3-

Chome, Chuo Ward, since 20 January 1947. During the period from January 20 to June, 1947, he threatened the operators of cabaret with the backing of Sekine Gumi and entertained other Sekine's followers almost every day. The entertainment expenses are roughly estimated at about ¥ 200,000. When the police made a raid on Sekine Ken, the boss, at the beginning of July this year, he tried to escape the meshes of the law, hiding himself among the gamblers spreading over the whole country. As he could not hide himself from the thorough zoning investigation, he reported himself to the police on 30 September. He was arrested.

2. Osaka Prefecture also has launched upon the control of terrorists since June and the police have arrested the following up to the end of September:

The police confiscated many deadly weapons including 3 Japanese swords, 4 revolvers, and others.

The principal arrests are as follows:

1. Fujimura Tadao, formerly a boxer aged 37, organized a gangster group named NANDO Society composed of about 50 members. With the basis of operations in the gay places such as Shinsai Bashi, Rotonbori, and others, he threatened restaurants, cabaret, and others together with his followers and indulged himself in drinking and eating without payment. His followers acted as bodyguards they threatened the operators of restaurants and cabaret on the false charge of their engaging in black market operations. He and his followers blackmailed several ten thousands yen. He constructed buildings on his own authority at the sites to which he has no title. He swindled several hundred thousands yen or royalty. He was arrested together with his 12 followers.

2. SOH Kishaku, a Korean aged 24, organized a gangster group called Hanshin Minami Ikke together with his 11 followers. They attacked on Shima Gumi, gangsters for their territory at 5:30 PM, 11 May 1947. They destroyed Shima Gumi's Office, giving a loss of over 10,000 yen at the present market value. They also gave a serious wound or slight wound to the opponents which required a week or three weeks medical treatments. Eleven of his followers were arrested on the spot while they were doing

violation or intimidation at the free market of Umeda. One revolver, 21 bullets, and 2 daggers were confiscated at that time.

3. When the dance hall was opened at Honmachi, Minami-Ward, Osaka, by Kinoshita Yaichiro on 1 April, 1947, Tsunajima Gentaro, the boss of Glay Pary Shima Gumi, age 41, in conspiracy with his followers, extorted ¥ 5,000 from Kinoshita, threatening him that he would be in danger if he did not employ his follower as a body guard. He succeeded to convince Kinoshita to employ his follower as a body guard at the salary of ¥ 4500 per month. In conspiracy with HISADA Kinjiro, the boss of gangsters HISADA Gumi, he extorted ¥75,000--from Kinoshita and the band-master of his dance hall from the middle of April to the end of May. Tsunashima, Hisada and three of his followers were arrested.

Hyogo Prefecutre conducted a private inquiry during July and launched on the wholesale arrest of gangsters from 1 August up to 10 August. They arrested the following:

The principal cases are as follows:

(1) KAN Toshiitsu of Takagi-Gumi contractors and civil engineers and twelve others, extorted money from restaurants and eating place operators or ate or drank without payment, inventing a pretext on a slight matter. They had a basis of operations at the free market in Amagasaki City. They also fought with Shimiza Gumi, contractors and civil engineers, for influence of their territory.

(2) TSUKUDA Etsuji, contractor and civil engineer, and two others leased a site to be evacuated in front of the Abashi Station. He sold the site to others, without paying rent. He also extorted money from merchants in the free market.

(3) SAI Enkan, Korean, and five others, with their headquarters at the shopping street under the Government "L" Line of Motomachi. He did violence to and inflicted an injury to the proprietors of shops and restaurants and extorted money from them.

4. Kyoto Prefecture conducted a private investigation during July and made a wholesale arrest of terrorists from 1 August to the end of August.

Yokoyama Gumi gangsters, which had a territory in Hachimanhama City and Utsunomiza, engaged in the struggle and violation acts with the old influential gangsters, Ichiwaka Gumi. Recently, the follower of Yokoyama Gumi was murdered. The trouble settled down for the time being through the intermediation of Hyoto Gumi on 23 July. Yokoyama Gumi and Ichiwaka Gumi again started a bloody struggle in the evening of 23 July. On 24 July, upon hearing of the struggle, Hyoto Gumi got mad and was about to break into the office of Ichiwaka Gumi with the help of 30 followers. In co-operation with the Detective Section

the Uwajima Police arrested 89 scandals, including 45 members of Ichiwaka Gumi, 18 members of Yokoyama Gumi, and 26 members of Hyoto Gumi. The police confiscated 12 Japanese swords, 6 bullets, 7 daggers, 2 spears, etc.

6. In the wholesale arrest from 21 July to the end of July, Hyogo Prefecture arrested the following:

BOKY Shoko and four guards of the stall shop keepers intimidated 185 stall shop merchants and extorted 170,000 Yen from them. Watch the backing of newspaper TERA I Shigeru, age 41, president of evening paper, Dai Ichi News, blackmailed and extorted from them over ¥ 3000 from the beginning of June to the middle of August, 1947. They also stealed over ¥ 10,000.

8. Miyagi Prefecture conducted a wholesale arrest twice; three days in June and three days in July and arrested the following:

The gangster group composed of Takahashi Motoji, age 32 and 9 others, extorted ¥ 33,000 from the dance hall operators and others in Sendai. They also injured 18 persons.

SHIMADA Keiichi, age 22, organized a racketeer group called TOKAKE Gumi with 8 followers. From the end of May to the end of June they broke into a warehouse twice in the period and stole clothing and food estimated at ¥ 450,000. They also found bearing a revolver and a Japanese sword with an intention of committing robbery with violation.

11. Tochigi Prefecture conducted a private investigation from 7 August to 17 August. From 18 August to 30 of the same month they made a wholesale arrest.

Some of them blackmailed for stealing of rice and for sale of second-hand articles, a railroad man committed a theft with violation and a middle school student violated a woman, etc. The criminals were mostly juvenile.

The racketeer group headed by Serizawa Sadao, age 18, organized a racketeer group called Chidori Dan composed of 8 members. They did fighting with the delinquent juveniles in the neighboring village. A racketeer group called NAMIKI family was also arrested on charge of entrance to theatres and show houses without payment.

Some prefectures have made a sudden raid on racketeers or are contemplating it. We can expect a good result of the campaign in the future.

The principal arrests made in the sudden raids are as follows:

(1) Suzuki Kazuji, alias Icchan of Bloody Cherry Blossom, organized in Mie Prefecture a racketeer group called Chizakura Dan (Bloody Cherry Blossom) with 16 juvenile members of around 20 years old. Threatening the railroad officers, they used to ride a train without paying for ticket. They used to engage in every kind of vicious crimes such as violation, theft, injury, etc.

(2) A Saito and 18 followers organized a racketeer group called Mutsumi Kai in Shihatta City, Niigata Prefecture. With their headquarters in the amusement quarters, they used

to commit violation and intimidation. They were confiscated six Japanese swords. The police arrested the racketeer group, Karasu Kai, which interfered into business of merchants and gave injury to the people. Kantaro Kai, a racketeer, gave a disturbance to the violin recital of Miss Suwa Nezuko. They were also under arrest.

(3) Hori Yoshisuke, member of City Council of Gifu, had a considerable influence as a boss of street stall brokers. Together with his followers, he engaged in violence, injury and intimidation. They were arrested. Kitamura Suzugaro, a boss of Yamada family, is the gangster who has a considerable influence in and around Gifu City. A big gambling was taking place at his house with 20 members. They were arrested on the spot.

(4) Matsukawa Sakujiro, age 34, a follower of Genseiden family of Honjo Town in Saitama Prefecture, and three others, taking advantage of their multitude, confiscated ¥ 10,000 from 50 people. They were arrested.

(5) Asakura Sanji, a boss of street stall broker in Akita Prefecture, committed a violence and gave a wound to the restaurant operators in Akita City. He blackmailed the operators of free market and tried to confiscate ¥ 1,000,000 from him in relation to the lease right of the market. He failed in an attempt and was arrested.

(6) In Hokkaido District, 50 followers of the Nagai family, a street stall broker, started a fighting with

50 Koreans at Tanuki Street, the amusement center of Sapparo City, at 1:00 PM, 29 June. When they were just starting a hand-to-hand struggle with deadly weapon, the policemen of Sapparo Police Station arrested them with the help of M. P.

## II

THE GIST OF REFORMATION OF THE PRISON CODE, ETC.

With the enforcement of Japan's new constitution law, the legal system of our country is undergoing a wholesale reformation. The Prison Code Reformation Commission was established at the Ministry of Justice the other day. The Commission has been studying its reformation in view of the intimate relations with Criminal Code and Criminal Procedure Code, taking due consideration the reformation policy of judicial system and the recent scientific research conducted along the criminal affairs. The Commission has recently decided the following gist of reformation.

THE GIST OF REFORM OF THE PRISON CODE

Compiled by the Research Commission of the Prison Code of Ministry of Justice, 26 August 1947

- I
1. The Prison Code shall be divided into two parts: one relating to the prisoners waiting for trial and the other relating to the prisoners without personal freedom. The latter will be further sub-divided into the code of juvenile and the code of adult people. They are to be compiled as separate codes.
  2. The Prison Code will be entitled "Gyokei Ho" and the prison will be called "Keimu Sho."

3. The prison will be under jurisdiction of the Minister of Justice.

4. The present intermediate supervision organization will be legalized by the revised code.

5. The terms such as "Choseki-kan" (Imprisonment prison) Kinko-kan (the prison for unconvicted prisoners) and Koryujo (the detention room) used in the present Prison Code shall be abolished hereafter. (The essential difference in relation to the kinds of penalty will continue to exist as before.)

6. The substitute prison system shall be abolished. But for the time being, it will continue to exist for the the transitional period.

7. A special prison shall be established for imprisonment of patients suffering from tuberculosis, leprosy, and mental ailments.

8. As advisory organization, the Prison Commission (Keimu Iinkai) will be established in central and local districts.

9. For administration of provisional release, the provisional release research commission will be organized.

10. A consolidated scientific research laboratory will be established in a prison.

11. A regulation shall be made to lay down the title and duty of prison officers, requiring them to take a typical

attitude towards prisoners.

12. A rule shall be laid down to establish an organization for preliminary and supplementary education of prison officers.

13. It is to be regulated that the code shall stress the importance of protecting personal rights and education and culture.

14. A regulation shall be laid down to request the prisoners to observe the fundamental rule in a strict manner.

15. More scientific methods shall be adopted in regard to the classification of prisoners and their treatment.

16. The imprisonment system on a sliding scale shall be adopted in the revised code.

17. The provision shall be stipulated that the third party can bear the weapon of the prison officers.

18. The provision shall be made to clarify the object of prisoners' works.

19. Every measure shall be taken to protect the safety of labor.

20. The employment of prisoners shall be secured.

21. The fundamental rule shall be laid down that the prisoners pay their prison's expenses by their own expenses as possibly as they can.

22. The prisoners who engage in labor have a claim to some fixed compensation.

23. The provision shall be made that the prisoners can take a furlough or vacation.

24. To safeguard the prisoners' health, the prisoners must take the compulsory physical examination.

25. To secure the prison's hygiene, the prison can seek for the co-operation of university, other research organizations and of the public protective organizations.

26. The measure shall be taken to secure the fundamental principle of freedom in religion and to promote the healthy religion.

27. The special emphasis shall be placed to encourage the education of adults.

28. A proper amusement shall be given to prisoners.

29. A new system of prize shall be adopted.

30. With regard to punishment:

(1) A probation and a conditional release system shall be adopted.

(2) A new system shall be adopted for punishment.

(3) The punishment such as a decreased ration of foods and a strict confinement shall be abolished.

31. A close connection shall be maintained to safeguard the prisoners after release.

32. The prisoners and some of their limited relatives can submit an application for the provisional release of the subjects.

## Appendices:

## Items desired:

As a counter-measure against the increasing numbers of crimes after the war, the establishment of Crime Prevention Headquarters (Hanzai Taisaku Honbu) is hoped for for dual purposes of studying as many measures as they can find from the standpoint of criminal affairs policy and social policy and of controlling and readjusting the various measures submitted by each ministry.

II In executing the punishment of juveniles restricting their personal freedom, the following revisions shall be made besides the common items applicable to the adults:

1. The Code shall be entitled "The Juvenile Prison Code" (Shonen Gyokei Ho).
2. The object of the Code shall be determined and the meaning and the contents of punishment shall be classified.
3. A proper name different from the prison shall be adopted for the detention room of juvenile.
4. The objects of this Code shall be limited to those falling under Article 9 of "the Juvenile Criminal Code."
5. A special research organization shall be established under jurisdiction of the Minister of Justice for consolidated research works.
6. In order to take an appropriate measure for the

improvement in treatment, provisional release and the allotment of labor, the Juvenile Prison Commission, Provisional Release Research Commission, and the Labor Commission shall be organized.

7. In order to conduct a scientific research of personal qualifications, classification and treatment, an efficiently organized research establishment shall be established in prisoners' accommodations.

8. The fundamental rule shall be established regarding the duty and qualification of officers engaged in juvenile prison administration.

9. A guardian can be elected to whom co-operation can be sought for regarding the prison and protective organization of juvenile prisoners.

10. As a fundamental principle, a prisoner awaiting trial shall be detained in a single room at night. The detention at a single room shall be limited day and night.

11. The professional training shall be emphasized in manual work of prisoners.

12. The minimum ration shall be given required for the growth of prisoners.

13. Prisoners who have not finished compulsory education:

(1) A scheduled education shall be given to them.

(2) The superintendent of prison can certify those who finished a scheduled education as graduates of primary school or middle school.

(3) Those who certified as graduates shall be entitled as graduates of primary school or middle school, in application of other acts.

14. After the lapse of a slant term, a fixed term system shall be applied to the juvenile prisoners punished for an unfixed period.

Annexed Decision:

Desired Items:

A thorough protection shall be given to juvenile prisoners after release.

III           The Detention Code shall be compiled based on the present law and on the following gists.

(1) General Items

1. This code shall contain the principal items regarding the detention of prisoners awaiting trial.

2. Those who received a detention order shall be kept in a detention room (Miketsu Kakin Sho)

3. As a special case, the following shall be accommodated in a detention room if necessary.

(1) Those who were arrested or detained by order.

(2) The prisoners who have just been sentenced to the punishment restricting personal liberty (until

every preparation be made to transmit them to a person.

4. The detention house and the prison shall have a different accommodation and shall be treated as separate organizations.

As a fundamental principle, a detention house shall be separately established at different locations and equipped with separate accommodations different from prison. If special accommodation is difficult to make from financial reasons and others,

(1) The detention room shall be established at the annexed place of prison.

(2) The lock-up of the police station shall be substituted as a detention room.

5. The detention room belongs to the jurisdiction of the Ministry of Justice.

Judges, inspectors, and the representatives of barrister's association can inspect the detention house at any time. They can submit the necessary recommendation as to the treatment of prisoners awaiting trial.

6. The officers of the detention house shall be appointed from the persons of adequate knowledge and experience so as to insure fair treatment of prisoners awaiting trial.

The officers of the detention house annexed to prison can concomitantly be the officers of prison. In case the lock-up of police station is substituted for a detention

house, a regulation shall be made to specify the duty of Police Station Chief and policemen with regard to detention of prisoners.

7. The Court and the Public Prosecutor's Office shall report on treatment of prisoners awaiting trial and pertinent data to the detention house. The detention house shall report on the movement and physical and mental conditions to the offices concerned and vice versa.

## II

### ACCOMMODATION AND RELEASE

8. Except in the case of amnesty and the release due to the expiration of term, the detention and release shall only be made by a lawful document issued by authorized persons.

9. The prisoners, if the release order is issued, shall be released as quickly as possible not later than forenoon of the next day.

## III

### TREATMENT

10. Special attention shall be paid to prevent the desertion of prisoners and erasing of proofs by communicating with others. Any ill feeling between prisoners shall be avoided. The development and improvement of their treatment shall be duly made.

11. It is the duty of every prisoner to keep themselves clean and arrange their respective rooms in good order. They should observe the regulations established in the prison.

12. With regard to the detention room:

(1) As a fundamental principle, all prisoners shall have their own respective rooms as far as the prison's accommodation allows and as long as their health permits.

(2) Attention should be paid to keep the accomplice and the related criminals in a separate room.

(3) The male and female, juvenile and adult, first offenders, and many offenders shall be kept in the separate rooms.

13. No compulsory labor shall be charged to the prisoners awaiting trial. It is recommended to let them work at their own will in efficient and continuous manners, taking into consideration the adaptability to the type of work of the workers.

14. The prisoners are allowed to pay themselves for food and clothing. Those who cannot pay for their food and clothing are provided with by the Government. The food and clothing which they provided themselves with shall be restricted not to disturb the order and discipline of the prison.

15. The prisoners awaiting trial can invite a doctor at their own expenses and receive medical treatment.

16. The prisoners are allowed to subscribe for books, newspapers, and magazines at their own expense if this does not disturb the order and discipline of the prison.

17. The prisoners awaiting trial, if admitted necessary, can receive proper education.

#### IV

#### CORRESPONDENCE WITH OUTSIDE QUARTERS

18. Except in the case of prohibition by the Criminal Procedure Code, the interview and correspondence of prisoners with outsiders are, in principle, free, provided that it does not constitute crime and does not violate the discipline of the prison.

19. The details regarding interview shall be decided by the representatives of the detention room, court, Public Procurator's Board, and the local barrister's association.

20. It may be so stipulated that the interview can be allowed in the presence of witness and the correspondence be allowed after census.

21. The stipulation shall be made that the conspiracy of the prison waiting trial with a third party and the interchange of unlawful articles can be prohibited. If they do not agree to the order, the authority can resort to force.

## V

## TREATMENT OF THE PRISONERS UNDER THE SENTENCE OF DEATH

22. With regard to the prisoners under the sentence of death:

- (1) They shall be continuously accommodated in the detention room.
- (2) In principle, the treatment of prisoners under sentence of death shall be made corresponding to the defendant of criminal case.
- (3) The execution shall be made at the detention house.

## Auxiliary Decision:

## Items Desired For:

1. In case the execution of detention and the execution of sentence restricting personal liberty go side by side on one person, a proper article shall be established in the Criminal Procedure Code as to the treatment of such a defendant.

2. The regulation shall be established in the Criminal Procedure Code to the effect that the prisoners awaiting trial who have served out their time and who are to be discharged should be released in the forenoon of the next day.
