Fukuoka: Report the news.

Sasebo: On board the SEISHO MARU lying at anchor near Akazaki, Sasebo, fifty-nine (59) pounds of smuggled drugs valued at ten million yen (¥10,000,000) were found and seized on 1 August 1949. The two shippers SUZUKI ~~Okutsuru~~ of Kyo-machi, Sasebo-shi, and YAMAMOTO Goro of Kasuga-machi, Sasebo-shi were arrested. YAMAMOTO conspired on 5 June 1949 with two warehouse keepers on a repatriation ship then at anchor in Ebisu Bay (EX: Nagasaki-ken), NAKATA Tsukusu of Toyonaka-shi, Osaka-fu, and AKAMATSU Saki of Takarabe-machi, Kagoshima-ken, to undertake the smuggling of stowaways for twenty thousand yen (¥20,000) per capita and goods for three thousand yen (¥3,000) per luggage. For a Korean, SAI Taku, they took aboard forty-five (45) bales of goods valued at five million yen (¥5,000,000) and landed them at Pusan (EX: Korea). AKAMATSU was arrested on his return to Japan. The smuggling ring to which these culprits belong was proved to be a large-scale organization with Osaka and Kyushu Areas as its field of activity. Its members are forbidden under the penalty of death to betray the organization. The police stated that it would be absolutely impossible to make the arrested confess.

Writer states:

"The Kyoto Municipal Police Bureau is now investigating the smuggling case involving various persons including Koreans who were communicating by using a code between Korea and Hokkaido Province. The outline of the case is as follows:

1. Suspects:

RI Kisai (李熙載), smuggler, still at large, whose Japanese name is (高永年次郎), Morimoto-cho, Azabu, Minato-ku, Tokyo-to (東京都港区麻布十番); KIN Tokei (金東奎), smuggler, whose Japanese name is KANAYA Meika (金谷明花), care of EMMI Hikohei (遠見彦平) of 16 Daido-machi, Jogakuyo, Sakyo-ku, Kyoto-shi (京都市左京区篠町十六); UENO Mitsuru (上野 三) of the same address as KIN Tokei; OCHIAI Toraichi (落合 寅一), managing director of the KINSHI EMPITSU K.K. (キンシ鉛筆株式会社, Kinshi Pencil Manufacturing Co., Ltd.), Kitagojo Higashi 2-chome, Sapporo-shi, Hokkaido (北海道札幌市北五条東二丁目); OSANAI Yukio (小山内行男), the said pencil company president, Daimyomon-machi, Sagashaka, Ukyo-ku, Kyoto-shi (京都市右京区大門口町三丁目); OSANAI Harukichi (小山内春吉), and OSANAI Chuji (小山内忠治) managing directors of the pencil company, both living at the same address as OSANAI Yukio.

3. Smuggled goods:

Six thousand (6,000) Tsubo (Ex: 1 Tsubo - 1 sq foot) of Korean leather amounting to one million two hundred thousand yen (¥1,200,000) on 9 Jul 49 and thirty (30) cases of Kinsh, Pencils totaling one thousand nine hundred and twenty (1,920) gross; valued at six hundred thousand yen (¥600,000), were smuggled out on 21 Aug 48.

4. Furthermore, they are suspected of having smuggled one hundred (100) cases of Kinshi Pencils amounting to six thousand four hundred (6,400) gross, and a considerable amount of raw rubber during August 1948."

"OSANAI Yukio, his 2 brothers, OCHIAI Teraichi and TOMINAGA Kojiro, who were arrested by the Komatsu-bara Police Station of Kyoto, are ringleaders of the following case, so you are requested to send us reports after holding hearings immediately. We add that the Fushimi-Maru was seized by the customhouse here and we have investigated the case in which were involved ringleader KOBAYASHI and crew:

The outline of the case is as follows:

1. TOMINAGA smuggled out 30 cases each, which contained 50 gross of pencils aboard the Myoken-Maru which left Saigo, Okiroshima, Shimane Prefecture, for 'KYURYUHO', South Korea, in the middle of August 1948. TOMINAGA stayed at Kyuryuho;
2. OSANAI left Sakae, Shimane Prefecture for Kyuryuho at the beginning of September, 1948, on board the Myoken-Maru which carried 30 cases each, which contained 50 gross of pencils. He together with TOMINAGA returned to Atsukeshi, Hokkaido, on board the same boat which was laden with 3 tons of crude rubber;
3. The Kompira-Maru, alias Fushimi-Maru, loaded with 130 cases each, which contained 50 gross of pencils bought at Otaru and at Fushiki, left for Kyuryuho in the middle of November, 1948. OSANAI returned, but TOMINAGA stayed at Kyuryuho.
4. The Kompira-Maru left Kyuryuho for Hakodate in the middle of December, 1948 laden with 6 tons of crude rubber and 6 cases of ox hide. 3 tons of crude rubber and 6 cases of ox hide were unloaded at Hakodate. Another 3 tons were unloaded at Atsukeshi. TOMINAGA returned with OSANAI,
5. TOMINAGA smuggled out 63 cases each, which contained 50 gross of pencils, 43 cases containing toilet articles, 4 cases of unknown items and 3 other casks which were carried by the Fushimi-Maru from Hakodate to 'DOKUSEKI', South Korea, in the middle of March 1949.

- 1) The above-mentioned person thrice successfully smuggled crude rubber and supplied it to the Takamori Firm and also to MIKASA GOMU K. (三益ゴム会社, Mikasa Rubber Co.), Nippori 6-chome (日暮里六丁目).
- 2) For the above smuggling he borrowed the Taisho-Maru (大正丸) (103 tons) owned by Mr. HATAKEYAMA Gennosuke (畑山 源之助), Sakana-machi, 2-chome, Kesennuma Town, Motoyoshi County, Miyagi Prefecture (宮城県 本吉郡 気仙沼町二丁目) through the medium of a widow in the same town, whom he had cheated and seduced. The ship sailed off Misaki Port, Miura County (Ex: Kanagawa Prefecture) on 21 Nov 1947 about 2000.
- 3) When he returned in May 1948 he said that the ship had been confiscated by the authorities. It was a lie. He had sold it.
- 4) In Nov 1948, he managed to send another ship, named Shinko-Maru (進文丸) owned by Mr. TAKADA Sadayuki (高田 貞之) of Mikasa Co., on a smuggling trip. The ship departed Katsuura Port, Chiba Prefecture on 29 Nov 48.
- 5) I revealed the above facts to the Mikawajima Police several times, but they did not believe me."
